4. Finalization of Tenders will be by way of negotiation by the Tender Committee. The decision of the Tender Committee in that regard shall be final.
 - a) Other things being equal, if more than one tenderer quote lowest minimum amount of Monthly Remuneration and found suitable by the Tender committee, the contract shall be allotted on the basis of LOTTERY.
 - b) Period of contract is TWO years from the date of commencement, and extendable One more year based on the satisfactory performance.
5. The EMD should be paid through a Demand Draft obtained in favour of "Accounts Officer, T.G.S.R.T.C. Medak Region, Sangareddy" payable at Sangareddy, as specified in the Tender Notice.
 - a) The cost of the Tender form is Rs. 885/- (750+135 GST)
 - b) The interested parties/bidders may inspect/visit the premises before submitting the Tender Form, and tenderers are required to make themselves fully conversant with the eligibility & terms and conditions, so that no ambiguity arises at a later date in this respect.
