- 03) The period of Contract is Two (02) years and extendable for One (01) more year based on satisfactory performance of the Contractor for Item Nos. 1,2,3,4 & 6.
- 04) The period of Contract is Three (03) Years and extendable for Two (02) more years based on satisfactory performance of the Contractor for Item No. 05.

Terms and Conditions:

1. The prescribed Tender Forms may be downloaded from the website www.tgsrtc.telangana.gov.in (Tenders) from **19.01.2026** onwards.
2. The Cost of Tender Form for each activity is Rs.1180/- (cost Rs.1000+Rs.180(GST), for which a Demand Draft can be "drawn in favour of Dy.Chief Accounts Officer, TSRTC, Secunderabad Region for each Depot/Unit separately which is to be enclosed with EMD amount payable and along with the Tender application at the time of submission of Tender Form.

3. The EMD amount shall be drawn through Demand Draft only in favour of Dy.Chief Accounts Officer, TSRTC, Secunderabad Region. In the event of EMD enclosed is less than the stipulated amount in the Tender Notification, it shall be forfeited and retained in the Corporation Account.
4. The filled in Tender Form shall be dropped in the Tender Box in the Office of the Regional Manager, Hyderabad Region, 2nd Floor, Kachiguda CAC, Hyderabad from 10.30 am to 02.00 pm on **05.02.2026** and the box will be opened at 03.00 pm. On the same day in the presence of the Tenders or their authorized representatives.
5. Other things being equal, if more than One Tenderer quotes same rate and found suitable by the Tender Committee, the Contract shall be allotted on the basis of LOTTERY. The Contractor must have GST Registration and PF,ESI Registration (wherever is applicable).
6. The Contractor shall claim 12% Employer's Contribution from Government of India under PMPRY Scheme in respect of new employees registered with EPFO w.e.f 01.04.2016 and up to 31.03.2019 and engaged by them to work in TGSRTC. The Corporation will not reimburse the same to the Contractor.
7. Tenderer, who purchase the Tender Form, has only to submit the Tender Form. Otherwise, the Tender will be rejected. The Tenderer has to enclose a copy of his PAN/GST Registration.
8. The detailed Terms and Conditions and Job Description relating to the above mentioned work Contracts can be downloaded along with the Tender Form/Application from website.
9. The Corporation reserves the right to cancel Tenders without assigning any reason thereof.
10. The Tender Committee reserves the right to alter/modify the period of contract mentioned in the Tender Notice at the time of finalization of Tender.
