2. Finalisation of tenders will be by way negotiation by the tender committee with each of the Tenderers and decision of the Tender Committee in that regard shall be final.
3. The EMD amount is payable through Demand Draft drawn in favour of Accounts Officer, TSRTC, Adilabad, Drawn Branch UBI Main Branch, Adilabad and the DD shall be submitted along with Tender Forms. Failure to enclose the Demand Draft to the tender form will be rejected. The EMD amount shall not carry any interest.
4. In Case the EMD paid by the Tenderer is less than what is stipulated or the EMD paid through other means i.e. in a manner other than the stipulated in the Notification, the tender will be rejected.
5. The EMD amount of unsuccessful bidders will be refunded after finalisation of tenders, without any interest.
6. GST No. must be enclosed and GST should be payable in addition to licence fee every month for any further information/clarification please contact RM's Office, Adilabad.

The Tender Form duly filled in all aspects shall be placed in the Tender Box kept in the office of the Regional Manager, TSRTC, Adilabad upto **14.00 hours on Dt: 11.02.2026** and the same will be opened at 15.00 hours on the same day in the presence of Tenderers OR their Authorized representatives.
9. The tender application received after the stipulated date & time will not be accepted.
10. The Management reserves right to reject any or all the Tenders without assigning any reasons.

As per Cir No.IR2/122(3)/2014-PO(IV),Dt:05.11.2014,"The Corporation will meet the total additional expenditure that arises due to increase in minimum wages and the corresponding increase in Employer's contribution towards PF,EDLIF and ESI and no enhancement of profit margin will be allowed on the corresponding increase in minimum wages, as and when the minimum wages are enhanced during the Contract period".
