2. The cost of tender forms Rs. 1180/- (1000+18% GST), the EMD amount shall be drawn through Demand Draft only in favour of Dy. Chief Accounts Officer, TGSRTC, Hyderabad Zone or by the way of cash at DY.CAO's Office, Hyderabad Zone, Uppal . In the event of EMD enclosed is less than the stipulated amount in the tender notification, it shall be forfeited to the corporation.

The filled in tender form in all respect addressed to Works Manager, TGSRTC ZWS/UPL duly sealed shall be submitted in the tender box in the Tender Box kept in the office of TGSRTC, Rangareddy Region, MGBS, Hyderabad from 10.30 hrs up to 14.00 hrs on 04.02.2026 and the box will be opened at 15.00 hrs on the same day in presence of the tenderers or their authorized representatives. The Name of the work contract and place shall be mentioned invariably on the cover.
4. The remuneration for providing Skilled, Un-Skilled and Semi-Skilled works with PF, EDLF, ESI & 7% profit margin are included in the tender notification.
5. In case the amount quoted is less than the above mentioned in the tender notification the tender will be rejected, since the value of the contract amount includes the minimum wages, PF/ESI with profit margin other thing being equal, if more than one tenderer quotes same rate and found suitable by the tender committee the contract shall be allotted on the basis of LOTTERY. The contractor must have PF, ESI registration and valid Labor License (Form-VI).
