The filled in Tender form shall be submitted in the Tender box in the Office of the RMs Office, Old Bus Station TGSRTC, KMM from 10.30 Hrs up to: 14.00 Hrs. on 05-06-2025 and the box will be opened at 15.00Hrs on the same day in presence of the tenderers or their authorized representatives at New Bus Station, Khammam.
- 05.In case EMD paid by the tenderer is less than what is stipulated in the tender notification or the EMD paid through other means i.e. in a manner other than the stipulated terms and conditions, the tender will be rejected besides forfeiting the EMD.
- 06.In case the amount offered is less than the amount mentioned in the Tender Notification, the tender form/application will be rejected since the value of Contract amount includes the Minimum Wages, PF/ESI with profit Margin. Other things being equal, if more than one Tenderer quotes same rate and found suitable by the Tender Committee, the Contract shall be allotted on the basis of LOTTERY.
