03. The EMD amount and Tender form Fee shall be drawn through Demand Draft only in favour of ACCOUNTS OFFICER TGSRTC, KHAMMAM. From (ANY NATIONALIZED BANK). *In case of failure to enclose the Demand Draft, in original to the Tender form/application submitted, will be rejected. The EMD amount shall not carry any interest.*

04. The Filled in Tender Form shall be submitted in the Tender Box in the Office of the RMs Office, Old Bus Station TGSRTC, KMM from 10.30 Hrs up to 14.00 Hrs. on 11-09-2025 and the box will be opened at 15.00Hrs on the same day in presence of the tenderers or their authorized representatives at New Bus Station, Khammam.

05. In case EMD paid by the tenderer is less than what is stipulated in the tender notification or the EMD paid through other means i.e. in a manner other than the stipulated terms and conditions, the tender form will be rejected besides forfeiting the EMD.

06. In Case the amount offered is less than/More than amount mentioned in the Tender Notification, the tender form/application will be rejected since the value of Contract amount includes the Minimum Wages, PF/ESI with profit Margin. Other things being equal and if more than one Tenderer quotes requisite/Prescribed rate and found suitable by the Tender Committee, the Contract shall be allotted on the basis of LOTTERY.

07. The Contractor must have PF/ESI registration and it will be renewed with valid date. Further, the Labour license obtained in respect of shops and establishment is not acceptable. The form VI issued by the Dy. Commissioner of Labour / Asst. Commissioner of Labour shall invariably enclosed for verification. (Wherever applicable).

08. The Tenderer has to enclose a copy of his PAN CARD, GST NUMBER, Aadhar Card, PF, ESI, Labour license (if any) etc., without fail.

09. The Persons Who are already Black Listed or against whom business complaints are pending will not be considered for allotment of the Contract.
10. The Detailed Terms and Conditions relating to the above mentioned work contract will be downloaded along with the Tender form/Application. (Downloaded).
11. The Tenderers Who are Offering tender for Buses sweeping and cleaning must be qualify in the Technical Bid and allotment should be based on the Profit Margin offered not more than 10%.

The Successful Bidder will be Selected is furnished hereunder:

- Through Lottery System for the works Sweeping Cleaning washing of Buses, HSD Oil Top Up, Asst to Mechanic works and OPRS System works.
- Who Quotes Lowest Rates for Chemical Washing of Buses to the Seat Fabric And The Interior Lining Of All Special Type Vehicles At Regular Intervals & To Remove Stains, Oil Muck & Accumulated Dust In Respective type of Buses. If firms more than One Agency quoted the same rate the Tenders will finalized on Lottery Basis.
