2. The EMD amount is payable through Demand Draft drawn in favour of "ACCOUNTS OFFICER, TGSRTC, NALGONDA" and the Original DD shall be submitted along with Tender forms. Failure to enclose the Demand Draft to the tender form it will be rejected and EMD enclosed less than the stipulated amount in the Tender Notification, The EMD shall not carry any interest.
3. The EMD amount of unsuccessful bidders will be refunded after finalization of tenders, without any interest.

4. The Tender form duly filled in all aspects shall be placed in the Tender Box kept in the office of the Regional Manager, TGSRTC Nalgonda up to 14.00 Hrs on 04.06.2025. The tender forms received after the stipulated date and time will not be accepted. The Tenders will be opened at 15.00 Hrs on 04.06.2025 in the presence of tenderers or the authorized representatives.
5. The Corporation reserves rights to reject any or all the Tenders without assigning any reasons. For any further information/ clarification please contact RM's office, Nalgonda.
6. Tenders are invited from the Man Power Agencies Registered with the Labour Department to provide men required to carry out various works (activities) of out sourcing works.
7. If the rate quoted is less/more than the above will not be accepted in the tenders.
8. In case the amount offered is less than the amount mentioned in the Tender Notification for the above items it will be rejected, since the value of Contract amount includes the Minimum Wages, PF/ESI with profit Margin. Other things being equal, if more than one tenderer quotes same rate and found suitable by the Tender Committee, the Contract shall be allotted on the basis of LOTTERY. The Contractor must have PF/ESI registration (wherever applicable).
9. Tenderers, those who purchased the Tender Form, has only to submit the tender form, other-wise the tender will be rejected. Tender form is not transferable.
10. The contractor shall compulsory submit the GST identification number for award of contract.
11. The Tenderer should submit separate tender form for each work along with DD/Banker's Cheque for requisite EMD. Otherwise the tender will be rejected.
12. Other things being equal, the tenderer who is holding PF and ESI Code Nos. issued by the competent authorities concerned shall be given preference.
13. The No. of Workers to be engaged may be increased /decreased based on the necessity.
14. The persons who are already black listed or against whom business complaints are pending will not be considered for allotment of the contract.
