TERMS AND CONDITIONS:

01. The prescribed Tenders forms can be obtained from the concerned Depot Manager's Offices of Nizamabad Region in respect all the working days during Office Hours **from 19.05.2025 to 29.05.2025**, duly paying the cost of tender form as applicable mentioned below.

- In respect of fuel outlets, the application can be obtained from the office of Regional Manager, Nizamabad duly paying Rs.5000/- in the form of DD obtained in favour of Accounts Officer, TSRTC, Nizamabad. A single processing fee is enough for all outlets in the Region as notified.
02. The EMD amount shall be drawn through Demand Draft only in favour of **ACCOUNTS OFFICER TSRTC., NIZAMABAD**. In the event of EMD paid is less than the stipulated amount in the Tender Notification, it shall be forfeited to the Corporation. The EMD shall not carry any interest. The EMD amount of unsuccessful bidders will be refunded after finalization of tenders, without any interest.
03. The filled in Tender form in all respects addressed to Regional Manager, Nizamabad duly closed shall be submitted in the Tender box in the Office of the RMs Office, TSRTC, NIZAMABAD **from 10.30 hrs upto:14.00hrs. on 30.05.2025 and the box will be opened at 15.00 Hrs** on the same day in presence of the tenderers or their authorized representatives. **The name of the work contract and place invariably mentioned on the cover.**
04. Separate Tender form has to be submitted for each counter and each contract. The Tenderer shall have to submit the Tender form only for the business of Cargo Parcel & Courier Service. There should be separate Tender form and separate sealed cover to be submitted. No combined quotations form multiple counters should be submitted and for any deviation the tender will be rejected.
05. The TSRTC Parcel & Courier Counter shall be allotted to the tenderer, who quotes highest license fee/rent to the stall/counter, and fulfilling all other terms & conditions. The tender committee shall negotiate with the higher tenderer to increase the offer.
06. Tenders are invited from the Man Power Agencies Registered with Labour Department with valid license to provide men required to carry out various works (activities) of out sourcing works for sl.No.1 to 5. The remuneration of providing skilled, Unskilled and

Semi Skilled works with PF, EDLIF, ESI and 7 % profit margin are included in the tender Notification. If the rate quoted is less than the above will not be accepted in the tenders.

07. In case the amount quoted is less than the amount mentioned in the Tender Notification in respect of sl.No.1 to 5, the tender will be rejected, since the value of Contract amount includes the Minimum Wages, PF/ESI with profit Margin. **Other things being equal, if more than one tenderer quotes same rate and found suitable by the Tender Committee, the Contract shall be allotted on the basis of LOTTERY.** The Contractor must have PF & ESI registration (wherever applicable).
08. Tenderers who purchase the Tender Form, shall submit the tender form on their name only. Other-wise the tender will be rejected. The tenderer has to enclose a copy of PAN CARD & Aadhar Card & GSTIN registration number.
09. The tenderers should submit separate tender form for each tender along with DD/cheque for requisite EMD, otherwise the tender will be rejected.
10. Other things being equal, the tenderer who is holding PF an ESI code Nos. and Labour license and GST No. issued by the concerned authorities shall be given preference.
11. The contractor/Agency has to quote individual applications for each contract.
12. The No. of workers to be engaged may be increased/ decreased based on the necessity/Circumstance.
13. The detailed Terms and Conditions relating to the above mentioned work contract will be supplied along with Tender form/Application.
14. The family members & close relatives of TSRTC Employee directly or indirectly are not permitted to participate in the tenders.
15. **The contractors whose past credentials are not good and involved in serious irregularities/ misappropriation etc., in respect of statutory benefits and issued with notices/block listed shall not be allowed to participate in tenders. In case of participation, their tenders will be rejected summarily on that ground alone.**
